PENALTY FOR NON MAINTANENCE/ DAMAGING IN NMB AREA.

1. Stocking any kind of materials on public Road under Nalbari Municipal Board area (Brick, Quarry Sand, ordinary river sand, Rod, Bamboo etc.)	
1st day after	Rs. 500.00
2nd day after	Rs. 1000.00
3rd day after	Rs. 1500.00
after 4th days if materials laying on road will be recovered by NMB and seized.	

PENALTY FOR DISPLAYING GOODS ON FOOT-PATH / ROAD OR ANY ILLEGAL EXTENTION.

1st day after	Rs. 500.00
2nd days after	Rs. 1000.00
3rd days after	Rs. 1500.00
If materials not rectified after 3rd day concern proprietor's Trade License will be cancelled and such goods seized.
